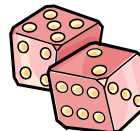
When: March 16, 2013, 6:00 pm - 10:00 pm

- Saxon's sponsored raffle for a lovely piece of jewelry

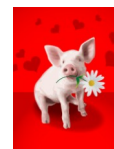

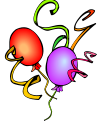
